All examinations will commence at **8.30 a.m.**, unless if there is a clash in the timetable, the commencing time for afternoon session is at **1.30 p.m.** On **FRIDAY** the commencing time will be at **2.00 p.m.** Candidates should report to the invigilator **15 minutes before** the commencement of the examinations.
3. It is the **RESPONSIBILITY** of each candidate to retain the **attached timetable** and be present at the designated venue and date(s)/time of the examination. The Examinations Department **WILL NOT contacting** the candidates to remind again about the venue and dates/time of subject(s) enrolled, **UNLESS** there are any changes of venue and dates/time of the examination.
4. The private candidates must collect their result slips and certificates from the Examinations Department, Ministry of Education, Negara Brunei Darussalam once the results are announced.
5. Candidates' identification will be checked by the Examination Supervisor / Invigilator before he / she is allowed to enter the examination room. Candidates are therefore advised to bring along with them their Identity Cards.
